



The session highlighted the vast potential for growth, networking, and partnership-building at major trade fairs in Germany and Austria in 2025.




KDWV ADDRESSES THE LONG WAITING LINES AT THE MERDARE BORDER

PUBLIC CONSULTATION ON THE DEVELOPMENT OF KOSOVO'S FINANCIAL MARKETS FRAMEWORK

The public consultation for the "Concept Document for the Development of the Regulatory Framework for Financial Markets," initiated by the Government of Kosovo as part of the National Development Plan, is now open. This initiative aims to create a sustainable and effective legal framework for the capital markets in Kosovo.

This document outlines the key issues in building an effective legal structure for capital markets in Kosovo. It seeks to provide new financing opportunities for businesses, encourage discussions on the benefits and challenges of capital markets, and guide the development of the legal framework in this area.

"TOWARDS A SUSTAINABLE FUTURE: KOSOVO'S STRATEGY FOR ENERGY TRANSITION AND CONSUMER PROTECTION"

On November 6th, experts gathered for a significant discussion on Kosovo's energy transition, organized by the Institute for Development Policy (INDEP) and supported by Heinrich Böll Stiftung (HBS). The event focused on addressing critical issues surrounding energy poverty and environmental challenges in the country.

The report presented at the event emphasizes the urgent need for targeted protections for vulnerable consumers struggling with high energy costs. It outlines plans for subsidies, energy efficiency improvements in housing, and support for renewable energy solutions that can help reduce long-term energy bills. Given Kosovo's heavy reliance on lignite, the transition to cleaner energy sources is crucial not only to alleviate energy poverty but also to protect public health and reduce environmental costs.

Key goals of Kosovo's energy transition strategy include achieving 35% renewable energy by 2031, primarily through wind, solar, and biomass. The strategy also aims to improve air quality and strengthen energy infrastructure to enhance energy security. By focusing on enhancing consumer protection, especially for vulnerable groups, and advancing energy efficiency, the strategy seeks to reduce the country's dependence on lignite. This transition is essential for fostering a sustainable and secure energy future for Kosovo.

IMF MISSION REVIEW: ECONOMIC INSIGHTS AND FUTURE DIRECTIONS FOR KOSOVO

The IMF Third Review Mission for Kosovo's Stand-By Arrangement (SBA), Resilience and Sustainability Fund (RSF), and Article IV Consultation took place from October 28 to November 12, 2024. During the visit, the IMF evaluated Kosovo's economic progress and engaged in discussions on key reforms.

On November 8th the IMF mission presented its analytical work on four critical topics that have been central to Kosovo's economic discussions:

- 1. **Financial Buffers in a Euroized Economy** The session explored the importance of maintaining financial stability in a country with a predominantly euroized economy.
- 2. Challenges of Pension Reform in Kosovo The IMF team discussed the complexities of pension reform in Kosovo and proposed potential solutions for ensuring the system's sustainability and fairness.
- 3. Labor Market, Migration, and Gender This presentation focused on the dynamics of Kosovo's labor market, the impact of migration, and the challenges related to gender disparities in the workforce.
- 4. ECB Monetary Policy Pass-through to Bank Interest Rates

 During Tightening The final topic examined how European

 Central Bank (ECB) monetary policies affect interest rates in

 Kosovo's banking sector, especially during tightening phases.

These discussions provided valuable insights into Kosovo's economic challenges and possible pathways for growth and stability.


FINDING A FOREVER HOME FOR KDWV'S LITTLE FRIEND!
