Foreword by the Executive Director of KD WV, Ms. Nora Hasani

As you read through this report, I want to take a moment to thank our team, board members, and cluster members whose dedication and vision have driven KD WV's remarkable achievements this year. Together, we have made significant progress in shaping Kosovo's economic landscape and building a stronger, more impactful partnership with Germany.

One of the biggest highlights of 2024 was the 2nd German-Kosovar Economic Forum. With over 700 participants, a main program, and three parallel sessions, this event marked a significant step in fostering stronger business ties, providing a platform for exchanges between German and Kosovar businesses, highlighting Kosovo's growing role as a business partner in the region.

This year, we organized 40 events, further solidifying our position as a key player in facilitating strategic investments and cross-border collaborations. Our delegation trips to Germany were especially meaningful, including a successful event in Göppingen and the N4CEB delegation trip to Berlin, where we connected with important partners and opened new opportunities for partnerships between Kosovo and Germany.

In 2024, we focused on supporting businesses directly, assisting 37 companies with market entry strategies, and supported 4 Kosovar businesses in expanding to Germany. Through the Senior Expert Service (SES), we facilitated knowledge transfer, assigning 9 experts and managing 33 active requests.

This year brought many important milestones for KD WV, including providing 42 consulting services to members and non-members, leading up to KD WV registering for Value Added Tax (VAT).

In 2024, we focused on advocacy as well, holding 145 meetings and sending 17 letters to stakeholders to advocate for policies that improve Kosovo's business environment. We also launched Fintech Kosovo, a major step in diversifying the economy and supporting the fintech sector. Our publications, including the "Legal Guide to Investing in Kosovo," "Challenges of Accessing the Labour Market for Middle-Aged Women in Kosovo," and the "Market Analysis for Renewable Energy in Kosovo (Zielmarktanalyse)" provided valuable insights for investors and decision-makers.

Through these initiatives and partnerships, we have worked to create a more transparent and sustainable business environment in Kosovo.

This year's achievements are a testament to the dedication and teamwork within KD WV. I'm incredibly proud of what we've accomplished together and grateful for the opportunity to contribute to our shared mission, supported by valuable partnerships along the way!

13th General Assembly of Members 2024

On June 6th, the German-Kosovar Business Association's (KDWW-OEGJK) Member Assembly held its 13th Annual General Meeting.

During the General Assembly, the achievements of KDWW in 2023 were showcased, highlighting its influential advocacy role in 16 working groups and public discussions, also over 100 advocacy meetings throughout the year. These efforts resulted in tangible outcomes, with proposals from the six KDWW-clusters being integrated into strategic plans, national legislation, and even state agency decisions.

In addition to its advocacy efforts, KDWW achieved significant milestones in strengthening German-Kosovar business relations in 2023, including:

KDWW not only promotes German-Kosovar economic relations but also supports good governance. During the 13th General Assembly, KDWW members had the opportunity to sign the Anti-Corruption Code, reinforcing their commitment to ethical business practices.

Highlight: 2nd German-Kosovar Economic Forum

The 2nd German-Kosovar Economic Forum, organized by KDWW and the German Eastern Business Association (OA), successfully brought together 706 participants, including 130 representatives from German companies. This marked a notable increase from the first edition in 2022, underscoring the growing interest in strengthening economic ties between Germany and Kosovo.

The Forum featured prominent speakers such as German Ambassador Jörn Rohde, Kosovo's Deputy Prime Minister Besnik Bislimi, Germany's Special Representative for the Western Balkans Manuel Sarrazin, and Bundestag member Peter Beyer. Additionally, Kosovo's Prime Minister Albin Kurti addressed attendees via video message. Leading industry figures from Allianz Group, BASF, and CELONIS, along with institutions like EBRD, IFC, and the Energy Community Secretariat, shared insights on investment opportunities and collaboration. Building on the €20 million investments announced during the 2022 forum, the event reinforced the commitment of both Germany and Kosovo to further economic cooperation and integration.

The Forum focused on three key strategic areas:

1. TECH SOLUTIONS: This theme explored innovations in digitalization, IT, business process outsourcing, fintech, and cybersecurity, emphasizing how both countries can leverage technology to enhance productivity, streamline operations, and foster entrepreneurship.

2. ENERGY SOLUTIONS: With the global shift toward sustainable energy, discussions centered on green technologies and renewable energy sources. The forum highlighted Kosovo's energy needs and the potential for German expertise and investments in the country's renewable energy sector. - Powered by N4CEB.

3. INDUSTRY SOLUTIONS: Focused on industrial advancements, this theme examined manufacturing modernization and improving production processes. It explored how German businesses can partner with Kosovo to expand market reach and capitalize on successful nearshoring opportunities.

In addition to the sessions, the second day of the forum offered two Master Classes:

- **"Mastering Mergers and Acquisitions – Strategies for Successful Integration"**, led by Andrei Krikliwy, focused on post-deal integration, including preparation, valuation, and integration strategies.
- **"Strategic Contract Negotiations"**, led by Dr. Philipp Wagner, provided participants with practical strategies to enhance their negotiation skills and navigate contract discussions effectively.

Both sessions received positive feedback for their relevance and practical application, helping participants address key business challenges. A total of 44 attendees participated in the Master Classes, 30% of whom were C-level executives.

The second day also featured three business breakfast sessions, offering valuable insights and networking opportunities:

- **Kosovo's Legal Framework for Commerce**, presented by Mahir Tutuli, President of the Kosovo Commercial Court.
- **Customs and Tax Regulations**, with Agron Llugaliu (Kosovo Customs) and Ilir Murtezaj (Tax Administration) addressing crucial business compliance topics.
- **Workforce and Labour Law**, where experts discussed labor-related issues and best practices for managing human resources in Kosovo.

These sessions not only provided essential knowledge but also facilitated connections among participants, fostering collaboration across sectors such as renewable energy, IT, and private banking.

The Forum served as a key platform for business leaders, policymakers, and industry experts to exchange ideas, identify emerging trends, and create synergies that can drive sustained economic growth and cross-border collaboration between Kosovo and Germany.

The German-Kosovar Business Association advises, supports, and represents German companies in Kosovo that seek to develop or expand their business activities. It also supports and advises Kosovar companies that trade with Germany and offer a wide range of goods and services.

6.3 Key Achievements in 2024

KDWV's advisory and consultancy efforts in 2024 delivered tangible results:

- **37 German investors** were guided in entering the Kosovar market
- **4 Kosovar companies** received support in navigating the German market, including assistance with regulatory compliance and strategic planning.
- Delivered **42 paid services** for both members and non-members, addressing their unique business needs.
- Generated **62 new business leads**, creating valuable B2B opportunities for Kosovar and German companies.

Through these efforts, KDWV continues to position Kosovo as an attractive and reliable partner for foreign direct investment, while also enabling Kosovar businesses to successfully establish their presence in Germany.

6.4 Service Packages for Investors - Investors Package

Since 2017, KDWV has been a trusted partner for German businesses entering the Kosovo market, offering bespoke investor packages tailored to their needs.

The KDWV investor packages go beyond basic support—they are a one-stop solution for navigating the complexities of market entry. From streamlining business registration and securing ideal real estate to providing legal and tax advice, as well as connecting investors with top local talent, KDWV ensures a seamless transition for German companies looking to succeed in Kosovo's dynamic business environment.

6.5 Women Going Digital

The "Women Going Digital" course, implemented by KDWV for Kosovo, empowers women with digital skills, fostering professional growth and inclusion in the digital economy. The course is ongoing, with 91 registered participants currently completing it. It has gained broad appeal across diverse sectors like Industry, Agriculture, and Administration, and has been promoted through academic institutions across Kosovo. Of the 91 participants, 21 have already been certified, equipping them with essential digital skills to enhance their career opportunities and contribute to a more inclusive digital workforce.



Advocacy and Government Relations

The Advocacy and Government Relations Department at KD WV, through its six clusters and three networks, made significant impact in 2024 to strengthen the representation of the German-Kosovar business community.

7.2 Advocacy results

KD WV has proactively contributed with comments on strategic documents, draft laws, and various administrative guidelines. Continuing from previous work, some of the results are reflected in:

- 1. Procedural Facilitation by ARBK as a Result of Our Meeting and Correspondence**
- 2. Contribution on Law on the Administration of Tax Procedures (Law No. 08/L-257) being submitted to the Constitutional Court by Ombudsperson, incorporating the feedback from KD WV and other business representatives.**

3. Data Privacy Advocacy Regarding Public Official Declarations

KDWV raised concerns that the Anti-Corruption Agency's publication of financial disclosures of public officials' family members may violate GDPR principles by compromising the privacy of individuals who are not public figures, and urged measures to protect sensitive information and prevent its unauthorized dissemination to safeguard fundamental rights.

4. Publication of a Labour Market Study

As part of our efforts to address workforce challenges, KDWV, in cooperation with the Friedrich Naumann Foundation, published a study on middle-aged women's access to the labour market in Kosovo, outlining key barriers and recommendations, which have been formally submitted to relevant institutions for action.

5. Following KDWV's advocacy with Kosovo's Ministry of Foreign Affairs and the German Embassy in Pristina, Kosovo is now accurately represented on German financial platforms—without association with Serbia—reflecting our commitment to rightful international recognition.

6. Ongoing Advocacy for Kosovo's Top-Level Domain

We remain steadfast in our advocacy for Kosovo to be granted a dedicated Top-Level Domain (TLD). While the goal has yet to be realized, our consistent efforts aim to secure this critical digital identifier, which would significantly enhance Kosovo's global digital presence and align the country with international standards.

Through these initiatives, KDWV continues to demonstrate its unwavering commitment to advancing advocacy efforts that protect our members' interests, foster legal reforms, and promote a thriving economic landscape in Kosovo.

7.4 Networks

7.4.1 Network for Clean Energy Businesses (N4CEB)

Established by the German-Kosovar Business Association with the support of the Federal Republic of Germany through the German Agency for International Cooperation (GIZ) in Kosovo, the Network of Businesses for Clean Energy in Kosovo (N4CEB) serves as a vital platform for addressing challenges and exploring opportunities in the clean energy sector.

Through regular dialogues, business breakfasts, delegation visit and workshops, N4CEB successfully connected key stakeholders, including government institutions, industry experts, and private businesses, fostering collaboration and addressing sectoral challenges. The network's activities led to valuable policy recommendations, with a special focus on overcoming legal barriers, energy certification, and enhancing business opportunities for its members.

7.4.2 The Clean Call Alliance (CCA)

The Clean Call Alliance (CCA) continues to be a vital network of call centers in Kosovo, working to promote the positive impact of the Business Process Outsourcing (BPO) sector. Established in May 2022, the Alliance was initiated through the collaborative efforts of the German Embassy in Pristina, the German-Kosovar Business Association (KDWV), and supported by the German Agency for International Cooperation in Kosovo (GIZ). Currently, CCA boasts six active members: Baruti, Concentrix, Kikxxl & Evrotarget, SPEEEX, Sutherland and Teleperformance.

Key Activities and Meetings in 2024



In 2024, the Clean Call Alliance (CCA) held two significant meetings addressing key topics for the Business Process Outsourcing (BPO) sector. The discussions focused on legal employment matters, strategies for diversifying the sector, and combating illegal call centers. A joint survey conducted by KDWV and the German Embassy in Pristina, explored fostering the German language in Kosovo among CCA members, producing significant results.

Looking ahead, the CCA remains committed to strengthening Kosovo's position as a competitive BPO destination. Its key objectives include expanding international collaborations, fostering a highly skilled workforce through the VET program, addressing challenges such as illegal call centers, and promoting Kosovo's customer service industry on a global scale.

Through these efforts, the CCA aims to drive sustainable growth and innovation within the sector.

7.4.3 Fintech Kosovo (FI-KS)

FinTech Kosovo (FI-KS) was founded this year through the collaboration of four trailblazing FinTech companies in Kosovo: Numarics, OneFor, Swinto, and Paysera. With the support of the German-Kosovar Business Association (KDWV-OEGJK), the initiative quickly built a vibrant network of member companies, united in their mission to drive innovation and foster growth in the financial technology sector.

FI-KS was established with the goal of advocating for improved regulation within Kosovo's FinTech sector, striving to create a supportive legal and institutional framework that fosters innovation and enhances competitiveness. Its mission is to bridge the gap between technology and finance, cultivating an environment where financial innovators, technology leaders, and policymakers work together to transform the landscape of financial services.

Through this initiative, we are actively working to build a more inclusive, secure, and efficient financial ecosystem. By leveraging technology's potential, FI-KS aims to empower individuals, attract investments, and pave the way for Kosovo to become a regional leader in FinTech innovation.

7.5 Engagement with Policy Makers

KDWV has actively contributed to shaping the energy policy landscape through strategic initiatives. A key milestone was the signing of *The Partnership Declaration on Climate and Energy* in Berlin, an event in which KDWV's Executive Director, Nora Hasani, participated. Building on this foundation, a meeting was held with Kosovo's Minister of Economy to discuss the signed agreement in Berlin and advancing energy-related policies. Additionally, a N4CEB Workshop provided a platform for dialogue on critical technical issues, such as grid connectivity, enabling stakeholders to share insights and propose actionable solutions aligned with the principles outlined in the Declaration.

7.6 Cooperation with Institutions - Strategic Partnerships and Advocacy

KDWV - Office for Strategic Planning, Office of the Prime Minister of Kosovo, GIZ

Since August 2023, the German-Kosovar Business Association has been cooperating with the Office for Strategic Planning, Office of the Prime Minister of Kosovo, on the initiative 'Private Sector Involvement in Policymaking.' This initiative is part of the project for Administrative Burden Reduction, supported by GIZ in Kosovo, under which several joint events will be organized on this topic.

KDWV - Council for Economy and Investment, Office of the Prime Minister of Kosovo, supported by the Independent Secretariat of the Council, funded by the Swiss SECO and managed by GIZ in Kosovo.

As a member of the Council for Economy and Investment, KDWV supported the Council's Secretariat in 2024 by providing comments and recommendations during joint meetings and participating in Sectoral Forums organized within the Council. This is part of our ongoing Public-Private Dialogue initiative, which aims to influence foreign investments, increase exports, and improve the business environment.

7.7 Advocacy Initiatives

7.7.1 Advancing Integrity: The German-Kosovar Business Association's Commitment to Anti-Corruption

The German-Kosovar Business Association is an active member of the Anti-Corruption Coalition, a project spearheaded by the Riinvest Institute with support from USAID-KMI. The Coalition represents a collective effort to drive anti-corruption initiatives forward in Kosovo.

With the support of the Association, 34 member companies have taken a vital step towards fostering a transparent and ethical business environment by signing the Anti-Corruption Business Code. Developed in collaboration with business associations and companies across Kosovo, the Code outlines clear standards and practices to combat corruption on the supply side, promoting fairness and legality in business operations.

7.7.2 Strategic Partnerships and Agreements

This year, KD WV strengthened its collaborative framework by signing three Memorandums of Understanding on behalf of its network N4CEB, aimed at enhancing cooperation and advancing shared goals in clean energy development.

▪ MoU with Kosovo Energy Efficiency Fund (KEEF):

KD WV, through N4CEB, signed a Memorandum of Understanding with KEEF to strengthen cooperation on energy efficiency and green initiatives. The partnership focuses on fostering innovation in the private sector and promoting efficient information exchange.

▪ MoU with Balkan Green Foundation (BFG):

KD WV, through N4CEB, signed a Memorandum of Understanding with BFG to advance renewable energy, energy efficiency, and sustainable development in Kosovo. Through N4CEB, the collaboration will drive joint initiatives, encourage innovation, and improve information sharing.

▪ MoU with Renewable Energy Associations in the Western Balkans:

KD WV, through N4CEB, signed a Memorandum of Understanding with the Macedonian Association of Renewable Energy Sources, the Association of Renewable Energy Sources from Bosnia and Herzegovina, and the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ). This MoU aims to foster collaboration among the renewable energy associations in the Western Balkans as part of the "Green Agenda: Decarbonization of the Electricity Sector in the Western Balkans" project, supported by the German Federal Ministry for Economic Cooperation and Development (BMZ). The agreement underscores a shared commitment to advancing renewable energy initiatives and enhancing regional cooperation in the energy sector.

In 2024, KDWW continued its commitment to fostering meaningful business connections through participation in high-impact B2B meetings.

B2B Meetings within the Framework of BME 10th Purchasing Initiative Western Balkans (11-12 June)

In June, KDWW actively supported its members in participating in 20 focused B2B meetings during the BME Purchasing Initiative in Munich. Organized by the Association for Supply Chain Management (BME) and backed by the Federal Ministry for Economic Affairs and Climate Action, the event provided a platform for Kosovar companies—including **Automatics-KS, Hymeri Metals, Rronifer, and K-AKS**—to connect with German businesses, strengthening ties and fostering collaboration.

The KDWW delegation facilitated meaningful interactions, ensuring that Kosovar companies maximized their opportunities to integrate into German supply chains and build long-term partnerships.

B2B Meetings within the Suppliers Balkan Expo - SUBEX 2024 Conference (1st of October)

October 2024 marked a milestone for Kosovo, as it hosted **SUBEX 2024** in Pristina for the first time. The expo facilitated **around 150 B2B meetings**, with Kosovar companies achieving **38 individual appointments** with buyers. Discussions focused on building partnerships in key sectors, such as metalworking, and included a German buyer visiting two Kosovar companies on-site.

Organized with a focus on fostering regional collaboration, the expo provided a platform for meaningful connections between Kosovar businesses and international buyers, particularly in the metalworking sector. As part of the initiative, KDWW also supported the visit of a German buyer to Kosovo, who explored opportunities with two Kosovar metalworking companies.

This event demonstrates KDWW's commitment to driving decarbonization and industrial partnerships in line with global sustainability goals.

10.1.3 B2B Meetings within the “Expanding Renewable Energy Infrastructure” Regional Business Trip (4th of December)

On 4th December 2024, following the „Expanding Renewable Energy Infrastructure“ Conference in Skopje, KDWW welcomed a German business delegation to Kosovo as part of a regional business trip focused on renewable energy opportunities. This conference, organized under the patronage of the Federal Ministry for Economic Affairs and Climate Action, brought together stakeholders from North Macedonia, Kosovo, and Albania to present German innovations in renewable energy.

During the Kosovo leg of the trip, B2B meetings with Kosovar companies explored investments in solar and wind energy, energy storage technologies, and smart grid solutions. The Kosovar participants included KDWW member companies **Nexia, Electra KS, Unisolar, Zilonis, Elen, ProCredit Bank Kosovo, Notus, and Optima Energy Consulting**. The German delegation comprised prominent firms and institutions, including Elia Grid International GmbH, Eltec Green Energy GmbH, Fichtner, Sunset Energietechnik, energy & meteo systems, RPT Ruhstrat Power Technology GmbH, and the Fraunhofer Institute for Solar Energy Systems.

Key discussions focused on leveraging German expertise in photovoltaic panels, HVDC systems, and energy efficiency solutions to advance Kosovo's green energy transition. These meetings underscored the shared commitment to developing Kosovo's renewable energy infrastructure, fostering partnerships, and driving sustainable energy solutions in the region. This event highlighted Kosovo's growing role in the regional renewable energy landscape and reaffirmed the importance of cooperation in achieving shared sustainability goals.

10.2 Participating in Fairs

In 2024, KDWW supported Kosovar companies at the world's largest industrial trade fair in Hannover, Germany, where Kosovo was represented at the state pavilion. Three member companies—**Kosbit L.L.C, Imbus Peja L.L.C, and Proton Cable L.L.C**—showcased their expertise in the IT and metal processing sectors.

The participation of Kosovo's Prime Minister Albin Kurti and Minister Rozeta Hajdari highlighted the strategic significance of this event in promoting Kosovar industries internationally. Their visit to the Kosovar exhibitors highlighted the potential of these industries and emphasized Kosovo's commitment to fostering international business partnerships.

Through participation in such high-profile events, KDWW continues to support its members in expanding their global reach and strengthening Kosovo's industrial reputation.

10.3 Participating in Conferences:

7-8 FEBRUARY:

'Shaping the Future Agenda of Administrative Burden Reduction in the Western Balkans' Conference

The two-day conference on reducing administrative burdens in the Western Balkans focused on enhancing accessibility and quality through strategic reforms. The discussions highlighted the importance of a shared vision and commitment to putting user needs at the forefront, contributing to economic growth and citizen satisfaction. This conference, the first of its kind in Kosovo and its neighboring countries, emphasized stakeholder engagement in shaping regional reforms. It was organized within a co-funded EU and German project, implemented by GIZ in partnership with the Kosovo Government and the OECD SIGMA Programme.

19-20 MARCH:

Berlin Energy Transition Dialogue 2024

KDWV attended the Berlin Energy Transition Dialogue 2024, where Kosovo and Germany signed the Declaration of Partnership for Climate and Energy. The agreement, signed by Kosovo's Minister of Economy Artane Rizvanolli, Minister of Environment Liburn Aliu, and German Minister of State for Europe and Climate Anne Luhrmann, focused on bilateral cooperation in areas such as Kosovo's net-zero policy planning, energy transition, and participation in international climate processes like the UNFCCC and COP. The partnership also aimed to raise awareness about climate change and foster a fast and just energy transition.

24 APRIL:

Panel Discussion at ESNAF Association's 30th Anniversary

Nora Hasani participated in a panel discussion titled "Human, Technology, and the New Economy: Shaping the Future Together," organized by the ESNAF Association in celebration of its 30th anniversary. The discussion focused on the evolving intersection of technology, human potential, and economic transformation.

12 JUNE:

World Consultant Day

Nora Hasani, Executive Director of KDWV, delivered the keynote speech at World Consultant Day, focusing on the role of ESG (Environmental, Social, and Governance) principles in the private sector. She highlighted the importance of ESG in driving business growth both locally and internationally, the need for standardization for companies aiming to export, and the governance aspects of ESG, including new reporting requirements and sustainability challenges. Nora emphasized the opportunities for consultants in Kosovo to assist businesses in navigating the ESG landscape, particularly with the implementation of the Supply Chain Due Diligence Act in Germany, the EU's Supply Chain Law, and the Carbon Border Adjustment Mechanism. She urged companies to prepare for continued or increased exports.

19-20 JUNE:

Unchain Festival in Romania

Executive Director, Nora Hasani, participated in the Unchain Festival in Romania, focusing on the latest trends in fintech and the creation of a local fintech ecosystem in the region. The trip provided an opportunity to engage with various Fintech Associations and explore the potential for establishing a regional fintech association for the Western Balkans. KDWV was the sole representative from the six Western Balkan countries at the event.

2 AUGUST:

Webinar on “Potential in the Western Balkans for Investment, Trade, and Supply Chain Diversification”

KDWV presented in the webinar organized by IHK Dortmund and NRW Global, which focused on investment, trade, and supply chain diversification opportunities for German companies in the Western Balkans. Experts from local Chambers of Commerce in Kosovo (KDWV), North Macedonia (AHK Nordmazedonien), and Serbia (German-Serbian Chamber of Commerce) provided valuable insights into the regional markets. German company ODW-ELEKTRIK shared their experiences, offering best practices examples.

12 SEPTEMBER:

“Nearshoring through Decarbonization in the Western Balkans” Conference in Budva

KDWV attended the conference on “Nearshoring through Decarbonization in the Western Balkans,” where findings from a regional study were presented on how decarbonization and the Carbon Border Adjustment Mechanism (CBAM) could improve the competitiveness of the region. The conference included two panel discussions: one on the potential of nearshoring and the other on strategies for businesses to stay competitive through decarbonization. Kushtrim Grainca, Plant Manager of Munda Kosova, member company of the German-Kosovar Business Association (OEGJK), participated as one of the panelists.

24 SEPTEMBER:

“10 Years Berlin Process - The Western Balkans as an Economic Area on to the EU”

KDWV, together with the N4CEB delegation participated in the “10 Years Berlin Process - The Western Balkans as an Economic Area on to the EU” organized by the German Federal Ministry for Economic Affairs and Climate Action in Berlin. The forum, was opened by Federal Minister Robert Habeck, brought together representatives from the six Western Balkan countries (WB-6): Albania, Bosnia and Herzegovina, Kosovo, Montenegro, North Macedonia, and Serbia. It was held alongside the Ministers of Economy meeting as part of the Berlin Process, with support from the East German Economic Committee and BMWK, focusing on strengthening economic ties and fostering regional cooperation.

24 SEPTEMBER:

KDWV Participates in Ost-West-Forum BAYERN 2024

This year, KDWV had the privilege of participating in the Ost-West-Forum BAYERN 2024, one of the major events in Germany. The event took place in Regensburg, where Besarta Hyseni, our Head of the Department for Market Entry & Events, represented KDWV. Her participation focused on strengthening ties and exploring new economic opportunities for our members.

The forum, hosted by Christian Volkmer, Vice President of the Chamber of Commerce and Industry in Regensburg (IHK), provided a vital platform for enhancing economic cooperation between Eastern and Western Europe. It was a key opportunity for fostering cross-border collaboration and discussing promising opportunities that could benefit businesses in both regions. This event marked another step forward in KDWV's commitment to supporting regional economic development and integration.

01 OCTOBER:

Suppliers Balkan Expo (SUBEX)

Organized by AHK Skopje, in co-partnership with KDWW and DIHA, the Suppliers Balkan Expo (SUBEX) on 1 October in Pristina, brought together over 150 participants for B2B meetings, a panel discussion, and four workshops. The event focused on key topics such as industrial suppliers, food and agriculture products, financing, ESG, and the impact of the Supply Chain Law. SUBEX provided valuable insights and networking opportunities, helping businesses explore new market opportunities and enhance their operations in the Western Balkans.

18 OCTOBER:

10 Years of Berlin Process: Achievements (Missed) Opportunities, Way Forward

Executive Director, Nora Hasani, participated in a discussion reflecting on the impact of the Berlin Process over the past decade on Kosovo and the region. Alongside Felix Schwickert from the German Economic Team (GET) and Jeton Zulfaj, Kosovar Government Sherpa for the Berlin Process, they explored both the achievements and missed opportunities of the initiative. The event, moderated by Alban Hashani from Riinvest Institute and with opening remarks by German Ambassador Jörn Rohde, provided an excellent opportunity to consider the way forward for Kosovo and the region.

03 DECEMBER:

“Expanding Renewable Energy Infrastructure” Conference in Skopje

Organized by AHK Skopje, in partnership with KDWW and DIHA in the “Expanding Renewable Energy Infrastructure” conference in Skopje, organized under the patronage of the German Federal Ministry for Economic Affairs and Climate Action. The conference brought together representatives from institutions and companies across North Macedonia, Kosovo, and Albania. It focused on showcasing German solutions in renewable energy, with key topics including photovoltaic panels, energy storage technologies, and smart energy grid management. With 80 company representatives in attendance, the event facilitated regional collaboration and discussions on strategies to reduce emissions and promote sustainability.

22-24 APRIL:

TAIEX Workshop on Youth Guarantee in Athens Greece

The Workshop focused on priority topics for the implementation of the Youth Guarantee in the Western Balkans, sharing valuable experiences from EU Member States. Its objectives include providing an overview of Greece’s vocational education and training system, facilitating professional exchanges on work-based learning, and discussing challenges and solutions with various stakeholders to enhance the attractiveness of vocational education and reduce youth unemployment.

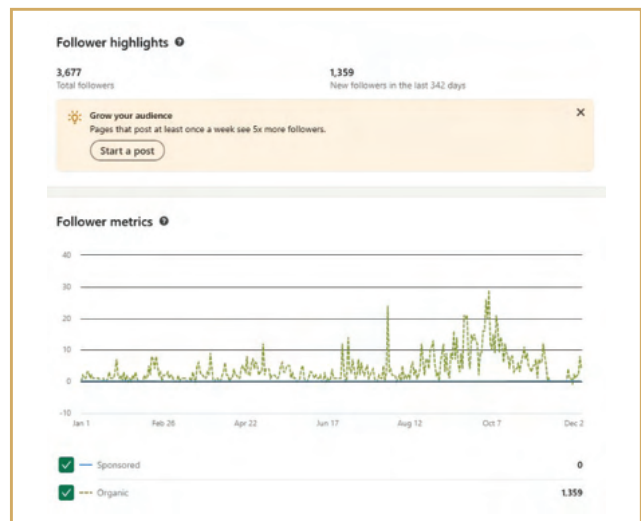
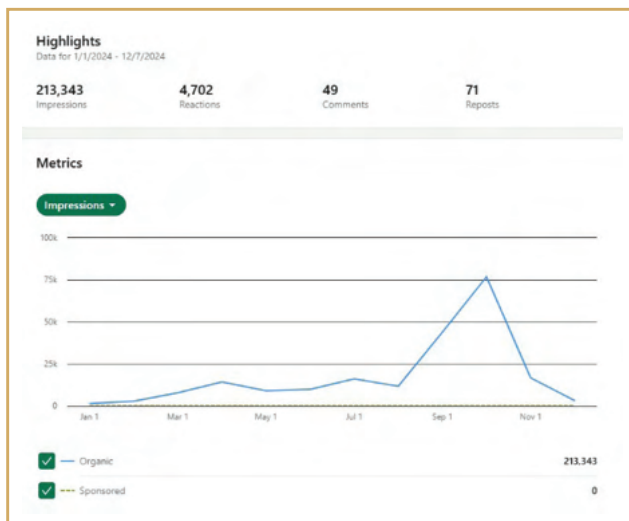
13. KDWV in Media

The highlight of the year was the Second German-Economic Forum, organized by KDWV on October 2-3, 2024, which garnered over **100** media mentions.

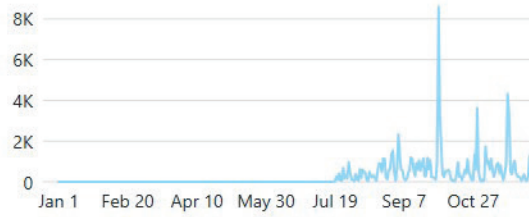

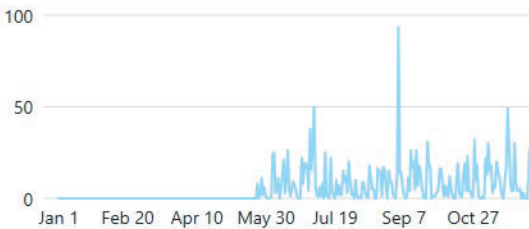
